How to Enter:** SPONSOR will have signage on site at all local Michigan events, staffed by event partner, Gail and Rice, that will promote taking a survey on site at events, for event goers to express their satisfaction with the event and the energy efficiency information they received at the event. The survey can be accessed by scanning the QR code that is visible on the signage, from any mobile device with internet capabilities. Mobile devices without internet capability will not be eligible to take the survey on site, but those event goers can access the survey from home using a laptop, desktop or tablet via URL that on site staff will provide. Once the event goer scans the QR code, they are taken to a mobile survey where they can answer prompts about their experience on site. First name, last name and email address are required to take the survey and enter the sweepstakes.
